***Abstract:** In 2016, the Liberian government delegated management of 93 randomly-selected public schools to private providers. Providers received USD 50 per pupil, on top of USD 50 per pupil annual expenditure in control schools. After one academic year, students in outsourced schools scored 0.18σ higher in English and mathematics. We do not find heterogeneity in learning gains or enrollment by student characteristics, but there is significant heterogeneity across providers. While outsourcing appears to be a cost-effective way to use new resources to improve test scores, some providers engaged in unforeseen and potentially harmful behavior, complicating any assessment of welfare gains.*

***Abstract:** This paper provides experimental evidence on the electoral effect of a large education reform in a developing democracy. Despite significantly improving school quality, the policy reduced the incumbent party’s presidential vote share by 3 percentage points (9%). This did not imply voters opposed the policy’s aims: its electoral effects varied positively with its school quality effects, and household surveys showed strong support. Instead, the reform lost votes by alienating teachers. It reduced their job satisfaction, eroded their support for the incumbent government, and disengaged them from political and electoral work. Where it caused greater political disengagement of teachers, it reduced incumbent vote share more. This paper demonstrates empirically the importance of political feasibility in the design of public service reforms.*

[“Secondary school access raises primary school achievement”](#)

Abstract: *I study the effect of secondary school access on primary school achievement, using Tanzania's implementation of a Free Secondary Education (FSE) reform. Drawing on the universe of standardized test scores as well as household survey data, I confirm that the reform increased secondary school access: secondary enrollments rose, household secondary education spending fell, and the transition premium for students from local elite families disappeared. I estimate the causal effect of secondary access on primary student achievement in a difference-in-differences framework, considering the treatment group to be students from families who failed to pay secondary school fees ex-ante. The reform increased primary pass rates and on-time secondary transition rates by about 3 percentage points each (from bases of 62% and 21%, respectively). Effects along the distribution of test scores for each exam subject suggest that students responded by optimally reallocating effort to clear the passing threshold. Results are not driven by supply-side changes to inputs at the school level, nor by changes to the size of student cohorts.*
